



## SADPA ExCo. Meeting

### Minutes

1. Opening and apologies:  
*NvdN opened the meeting. All Exco members present.*
2. Confirmation of previous SAPDA ExCo minutes:  
*Minutes confirmed and approved by all members.*
3. Matters' arising from previous minutes
  - a. **Website** – *Calendar, DSS, Sponsors done, rest still to do*
  - b. **2011 IDPA Africa Champs** – *Will discuss under 5a*
  - c. **Targets** – *DS to enquire about smaller targets (a la IPSC) for ranges with limited range distances/facilities*
  - d. **DMG rules** – *NVDN to add to website and send explanation via yahoo-groups. Also clarify the differences between IDPA and SADPA wrt divisions. Flash-hider larger than 1in. will be allowed provided that it's flash-hider only and not a compensator.*
  - e. **EXCO Vacancies** – *AGM notification to go out 21 days before date. Package to contain SOP's, last year's minutes, proxy and nomination forms.*
4. **Finalise agenda** – *DS requested to add reduced SSR factor under additional items.*
5. **General ExCo. matters**
  - a. 2011 Matches / SADPA 2011 Northern & Southern Nationals / Medals.  
*Nationals to consist minimum 10 stages and 120 rounds. Entry fee R250.00.  
Champs remain 14 stages 150 rounds. Entry fee R350 Champs.  
Criteria: 1 Classifier and 2 Leagues or 1 Classifier, 1 League and 3 clubshoots.  
Medals – New Champs & National medals. **ASR to follow up.**  
Proposal accepted to sponsor a couple of shooters from North to shoot in South and vice versa (will be done on basis of skill/participation/SO Duty).*
  - b. National Log / Provincial Colours / Association Colours.  
*SADPA can issue provincial and association colours without being part of SASSF, but cannot use emblems. **NvdN** must update the LOG asap. Will then take top 3 shooters provincially and nationally. Log to be produced from Nationals, classifiers*

*and postal shoots. Leagues to be added later. Need classifier final times from clubs.*

**NvdN to action**

- c. Dedicated status – minimum requirements  
*Discussion around “chancers” not shooting but using banked points for DSS. To be tabled at AGM. Points to remain positive on 31 Dec each year and a minimum of 10 points to be accumulated per year. Marge still holds the mandate to approve on behalf of SADPA Exco and will submit member names at Exco meetings.*
  - d. Clubs
    - DDPC – Assurance from Asif Tayob he will concentrate on growing club and membership in 2011
    - KSC – Allen Davies new chairman. **NvdN to follow up on last email sent to Deon Hignett.**
    - Conserv – to be given notice of lapsed membership and affiliation. **MH to action**
    - Rustenburg / Senekal / Mooirivier – New clubs in the process of starting up. **ASR will be visiting.**
  - e. AGM date – 5<sup>th</sup> March 2011 at JDPC 08h30. **MH to send out notice 21 days beforehand (11 Feb).**
  - f. Finances - *MH tabled expenses*
  - g. DSS – *MH tabled December issued DSS*
  - h. Website and outstanding updates – *FAQ section to be added.*
