  - a. Website – SADPA Landline to be updated. Also update sponsor logos. Email to clubs to ensure scores are submitted via YahooGroups. Alternatively, scores to be loaded to the website.
  - b. 2011 IDPA Africa Champs
    1. Feedback – positive feedback overall.
    2. Budget – Budget was tabled and accepted. Surplus of approximately R30k.
    3. Sponsors Certificates – Will be framed and distributed.
  - c. National Log – Nic to action.
  - d. Southern Champs – Entry Criteria: Classifier in the division the competitor wants to shoot in, plus any two additional shoots. Financial assistance from SADPA for Northern Competitors: SADPA will pay entry fee for all competitors belonging to non-Cape clubs. Medals: SADPA will arrange medals, with engraving. Scorebooks: SADPA will provide. Certificates: SADPA will provide. Timers: MH will request Gauteng members to take timers with. Range rental: To be paid as per normal.
  - e. 2011 IDPA Postal Shoot – To start on 27 Aug and end on 24 Dec. On IDPA website.
  - f. Targets – 100 large and unknown small left. 5,000 have been ordered, but storage remains an issue.
  - g. Safety Officers; A) J. Andre van Tonder re. NSO. No objection to the firearms training aspects, but will the rules be properly treated? NSO to include a classifier shoot as well, as is current standard club procedure. B) SO conduct: SO's should be mindful with regards to their conduct on the range. Language, tone etc is very important and SO's should set the example in general.

- h. Club Development – Rustenburg growth is exceptional, and will need another SO course as a result. NH/LM to engage. Enquiries have been received with regards to another club in the Durban/KZN area – NH to follow up. Enquiries from Langebaan as well. Timers can't be supplied until club has proven growth etc. West Gold (Fochville) has started a club. NH/Exco to visit in due course.
- i. Finances – Tabled by MH and accepted by Exco. Raffle proceeds to be paid over to Save the Rhino – media coverage to be done.
- j. Resignation and handover; A. Rosslee resigned with immediate effect as communicated at the Africa Champs. AR handed over all documents, endorsements etc. Website, letterhead, Endorsement forms etc to be updated asap – NvdN. Exco members thanked AR on behalf of SADPA for the time and effort put in over the past 12 years.
- k. Nigel Hulleman has been elected as acting chairman.
- l. Because of his dedicated involvement in matters related to SADPA admin and database, it was proposed that Danie van Huyssteen be co-opted as Exco member should he agree to it. NvdN to discuss and provide feedback.
